## ANNUAL GENERAL MEETING HELD AT STAFFORD BOAT CLUB.



The well attended meeting commenced with a warm welcome from the Commodore of Stafford Boat Club, John Mountford, who described how the Club had built up from nothing over the years by the efforts of it's members and was justly proud of what they had achieved.

The Association's President Geoff Ashton then formally opened the meeting. Chairman Paul le Blique gave his report (reproduced on page 2) then handed back to Geoff who presented the accounts. The reports from the other officers and those from the regions were then presented and are reproduced elsewhere in this issue of ALERT. The next item on the agenda was the election of officers and the President enquired if there were any members wishing to stand for election to any of the NEC posts. There being none, the existing officers were re-elected en-bloc. The position of National Treasurer was accepted by Midlands Region Treasurer, Graham Churton. Ken Bearpark had regrettably had to resign the Treasurer's position because of family pressures and his wife Heather had resigned as ALERT Editor. Geoff thanked them both for their past efforts. The vacant Editor's position was accepted by Graeme Bridge from the Bridgewater Motor Boat Club. With the formalities completed the delegates enjoyed an excellent lunch provided by the ladies of Stafford Boat Club.

The second half of the meeting was a presentation by Lynne Berry and Ruth Ruderham on the Canal & River Trust, a report of that presentation is given on page 12. There followed a Question and Answer session with some members concerned about the way the election for boater representation had resulted in a concentration of members from one large organisation which had a much larger remit than simply canal boating. The response was that the Trust must represent all aspects of the canals and rivers and that there would be opportunities to elect other members to the Trust at future elections.

## National Chairmans Report to AGM 2012

Looking back over the past year, I realise just how much time and effort we have spent supporting the move to CRT through consultations and user group meetings. It has been time well spent, as the terms of transfer are far better than we could have expected. The Transition Trustees, BW and the DEFRA Team are to be applauded for their success in giving CRT the best possible start. AWCC clubs are recognised as an integral part of the waterway community and we are assured that BW lease

agreements will be secure following their transfer to CRT.

The four members of Council elected to represent private boaters should be congratulated on their success, as theirs will be the responsibility to ensure that the CRT properly supports all private boaters, ranging from the occasional user to those who choose our waterways as their legal home. We should encourage our four Members of Council in this challenging task as their success or failure will be judged by a nation-wide boating community.

CRT is the future of our waterways and we in AWCC should continue to promote and support its cause as the only solution to years of under funding and restrictions imposed on BW.

I believe that CRT should adopt EA rivers in three years time, ensuring they too benefit from trust status to create a joined-up inland waterway system. An additional funding package will be required to meet the liabilities that EA Waters bring with them.

It was encouraging to see so many members at the AGM and I would like to acknowledge the time and work that the NEC and Regional Committees have spent supporting the association throughout the last twelve months,

### Consultations

Representatives from our clubs have attended British Waterways, A.T.Y.C., London Waterways Commission and other meetings during the year.

### London Waterways Commission

The- proposed river-walk is unlikely to be ready for the

diamond jubilee or the Olympic Games.

Cross-rail tunnel sections are to be manufactured near my club at Old Oak Common however the ready mixed concrete will be supplied by the Kings Cross Depot near S.P.C.C. these materials unfortunately are not to be moved on the canals, another missed opportunity which will lead to thousands of unnecessary lorry movements.

D.P. Ports who are building the massive London Gateway Terminal on the Shell-Haven site, plan to build a small depot at Greenford on the Grand Union and transfer

the freight between by water.

### The Big Waterways Cleanup campaign

This was launched early in February Theo Thomas from Thames 21 is to coordinate the volunteers this has been launched prior to the games for obvious reasons but it is hoped the legacy will last indefinitely.

### British Waterways

In my 2009 report I spoke about the proposed waterside developments for Brentford.

After many meetings the unique warehouse structure has been saved.

The new properties are laid out with spaces from the Land and the water. British Waterways should have negotiated more effectively on our

It could have been worse for those who take out 3 and 6 month licences had we not successfully objected to last year's proposed increases. These high costs combined with the economic situation are limiting younger people coming into boating. The average age of club members is rising all the time. This cannot go on forever. Recruitment of young people is vital to the future success of the clubs. I just wish I knew how to do it.

The move to C&RT is now well advanced (although delayed) with the council election closed last week. The

Last June the Project Leader, Damian Kemp, became ill and no meetings were held until October which Mark Stephens chaired. It was expected that another meeting would be forthcoming but in November we were all notified that there would be no further meetings of the group; in December Sally Ash, Damian Kemp and BW Technical Teams would consolidate proposals put forward by the group. Sally and Damian would then brief

Mark Stephens and BW of the outcome of this consolidation. Between January and May 2012 it is to be decided whether to endorse what had been agreed, with subsequent implementation – assuming BW/CRT agree. All along the group were saying implementation of the current law would help keep boats moving but there are not sufficient enforcement officers to be able to carry this out and there is no guarantee that this will be improved once CRT comes into force. Wiltshire County Council has invited people living on board within the County to a

meeting to be held at the end of February in Devizes. The focus of the project is to:

>understand the key issues facing live aboard boaters

>identify good practice and share learning to influence the delivery of key public services for the future

>tell your stories to a wider audience. One of the members of Pewsey Wharf Boat Club is going to the meeting and I hope to have more to report.

# PARLIAMENTARY WATERWAYS GROUP

## Parliamentary Waterways Group Meeting 15 March 2012

Allun Michael was in the chair, with several Members of Parliament in attendance from both Houses, including the current and several former Waterways Ministers.

It being the AGM, Allun Michael stood down as chairman and proposed that in future there should be co-chairs from Government and Opposition. Tony Baldry and Hue Iranca Davies, two former Waterways Ministers were accepted into the posts.

Richard Benyon, the current Minister then gave his statement, which was very similar to the one he had given in Feb on the subject of the financial settlement with the Canal and River Trust (CRT). (A detailed explanation was provided on the AWCC website at the time.) He thanked all concerned, including trustees, officials and user representatives for their co-operation in achieving what was a unique and robust deal. It was the best possible under the circumstances and unique in that it was to last for 15 years and that the principle of trust status retained cross party support. He confirmed that the CRT Order had been placed before Parliament on 29 Feb. It is my understanding that the £25M cash grant has been paid into the pension fund.

He did accept in questioning that CRT would require Government assistance for the foreseeable future. It did prompt a discussion on the estimate for charitable giving, which was set by Lynne Berry as £10M p.a. after 10 years. Tony Hales suggested that there would be a net loss (cost over income) in the first 2 years.

Hue Iranca Davies asked about the backlog of maintenance and another MP asked about executive pay levels. The Minister said that it was important that the BW assets were maintained in good condition for the future. He expected a small increase in D & E class assets in the next 2 years and then a fairly rapid decrease. On salaries, he said that it would be up to the Trustees and Council to regulate. Robin Evans added that money had to be spent as directed (by DEFRA) as part of the setting up conditions, e.g. maintaining existing assets as opposed to new restoration projects.

The length of the Parliamentary process was then examined. The Trustees are planning a formal launch at the end of June to fit between the Queen's Jubilee celebration and the Olympic Games. If this were not met, a rearranged launch in September would be much

less effective, as all the summer canal events would be over. The Chairman undertook to expedite a 40-day process, rather than a 60-day process as currently planned, if at all possible.

At the end of the session, questions from the floor were allowed and I was able to raise the subject of the correspondence between John Burrell and myself on behalf of AWCC. Put simply, CRT is not currently a charity as it is not registered with the Charities Commission, the Articles of Association lodged with Companies House are basic and not designed for a charity and do not mention a Council as part of the governance structure. Hence, the Council members have no powers whatsoever until substantial change is made. This has been discussed with Nigel Johnson of BW and basically, it is a 'roundtoit' problem.

The PWG was a very good place to give it a public airing. There were a largish number of MPs present, including former Waterways Ministers, so with the limited time available, I had to be brief, but being so I have found in the past often gets better results. Tony Hales had just set out the overall timescales, so I asked for a specific date when the legal matters, Articles of Association, etc, would be resolved. The politically correct answer of 28 March was given by Robin Evans (the same day as the proposed first meeting of the Council), but I was able to cause some amusement by commenting that it was of course the "right" answer. It helped underline the problem. However, he knows as well as the rest of us that he will now be held to it! It is of course an almost impossible target. Another target given by Tony was 20 March for registration as a charity, so we will see how they do with that one. I have made the point to many, including members of the press that producing a draft of the Articles could have been done weeks ago by a volunteer solicitor. I could have even attempted it myself! (But I am not volunteering now!) Note: none of the newly elected Council members were present at the meeting.

# COMMUNICATIONS

## Report to AGM 2012

As you may be aware, the AWCC has been without a Communications Officer for the past year, which has meant that a number of things that we had hoped to develop have not come to fruition. I hope that in the near future we will have new officers for this post, which will allow us to proceed with developing new services for AWCC Clubs and their members.

### AWCC Website

The website continues to attract a steady stream of visitors, averaging about 320 visitors per month. We suffered a few days outage during the year when the site was hacked by unknown persons and stopped working. With the help of our web hosts, we were able to find how the hacking had occurred, to rectify the problem, re-instate the website, and add a number of additional security features to reduce the likelihood of it happening again. The project to allow individual AWCC member access to the members area has not progressed this year due to lack of a full time Communications Officer. Hopefully this will be progressed in the near future. We would like to put much more information about Club events onto the website. If you have anything you would like to appear on the site, please forward it to the Communications Officer.

### Receiving ALERT Electronically

Last summer, we asked all Clubs whether they were willing and able to accept the AWCC Newsletter as an electronic PDF file, rather than by post. Clubs were asked if they would opt-in to receiving eMail notification that a new version of ALERT was available in the public area of the AWCC website for download and distribution to Club members. Any Club who chose not opt-in would continue to receive ALERT by post.

The idea received positive approval, and we have set up the service using MailChip, a free web-based service which allows us to set up mailing lists, create the notification eMails, and schedule the emails for distribution. Clubs are invited to opt in via a link to the MailChip website, and can opt-out at any time through a link which is included in any notification eMail.

To date, we have 48 Clubs signed up to taking the notification service. We would be pleased if all Clubs would take ALERT in this way, as it represents a significant cost saving and helps us keep AWCC membership fees down. *(especially with the impending hike in postage. Ed)*

As an additional service, we also offered a similar service to any AWCC member to receive the email notification personally. The link to subscribe to the service was published in the last ALERT, and is also available on the AWCC website. We currently have 57 individual subscriptions to this service, which is freely available to all members and interested parties, and we invite any AWCC member to sign up.

### Club Information Database/Handbook

The database has been used extensively this year to get Club information up to date. The databases is updated on a regular basis by Regional and Club secretaries as new information becomes available. If any Club would like to maintain it's own information online, we can arrange to them to be issued with a user name and password.

I would like to remind all Clubs that they have been sent a login and password to the members area on the AWCC website; up to date handbook information is stored as PDF files, including the standard handbook, the loose leaf page versions and the indexes.

# TECHNICAL OFFICER'S AGM REPORT

## Introduction

1. I apologise for being unable to deliver this report in person.
2. I have concentrated on extracting information from the incident data prepared by the Boat Safety Scheme (BSS) for 2011. When analysed, this data helps BSS plan its activity to address the risks from boats that have been inadequately constructed or maintained and used.
3. It is worth remembering that BSS is concerned only with the start of fire, the spread of fire, explosion and pollution.

## Accuracy of data

4. The data includes incidents relating primarily to boats used on inland waterways. Incidents on coastal boats are recorded where the craft may be of a type that could be used inland, or where the systems aboard may be common to those on inland boats.
5. The data cannot be considered as a complete record of incidents. Many minor incidents are not reported to any agency, or collated and published.
6. The review is based on 237 incidents, 206 on inland waterways and 31 on UK coastal waters.

## Carbon Monoxide (CO)

7. There were no fatalities resulting from CO incidents. CO continues to affect boaters, especially those living aboard. Engine exhaust fumes, heater combustion gases and solid fuel stove flue gases are the main sources of CO incidents.
8. A re-vamped CO leaflet will be released shortly and this will coincide with a new BSS web-portal and the use of social media.

## Fire and explosion

9. There was one fatal fire, on the Medway, which was started deliberately by the victim in an act of self-harm. 2011 has been the first year in at least a decade where no fatalities were recorded on boats inland, or on the coast.
10. A major cause of fires over recent years is deliberate fire setting. BSS records continue to show that around a quarter of fires on inland waterways boats are set deliberately.
11. Fires and explosions related to electrical installations is the highest ever at 17. Batteries are highlighted again; in 2011 there were seven battery explosions on inland boats.
12. Solid fuel stoves (SFS) their installation, maintenance and incorrect use continue to feature across the range of fire and CO incidents. *Already in 2012, five incidents linked to SFS have already been identified.*
13. BSS continues to work with its consultant and the solid fuel industry to promote good practice messages about safe installation and the correct use and maintenance of appliances and flues. BSS will also publish information concerning the choice, storage and use of fuels, as well as the safe disposal of ash and embers.
14. A major cause of fires over recent years is deliberate fire setting. BSS records continue to show that around a quarter of fires on inland waterways boats are set deliberately.

## Safety self-awareness (escape)

15. The risks from being trapped in a burning boat or sinking vessel appear under-appreciated. The locking of one escape route on the outside of the boat while the crew are sleeping on the inside is still commonplace.

# AGM PRESENTATION .....CANAL & RIVER TRUST



**Canal &  
River Trust**

Following this year's AGM, members were given a presentation by Lynne Berry, OBE, who represents the Transition Trustees followed by Ruth Ruderham, BW Head of Fundraising.

Lynne explained that the Canal & River Trust will be one of the biggest charities in the country. It will also be a **local** charity, therefore it is planned to launch the trust simultaneously at a minimum of 12 locations around the country including major national publicity events at Birmingham and the Pontcysyllte Aqueduct. Details of these events will be available through all usual waterways media. She hoped that AWCC boat clubs would get involved with events in their area. This could be achieved by forming links between local clubs and local Partnership Boards to share creative ideas.

The date was not yet confirmed as it would depend of how long MP's and the Lords took to pass all stages of the bill but it was hoped to launch towards the end of June.

Lynne thought that what had been achieved in respect of funding agreements and the 15 year commitment to the new Trust was unprecedented in her experience and showed the Government's determination to make the new arrangements work. What was also impressive was that this had all been done in such a short time scale.

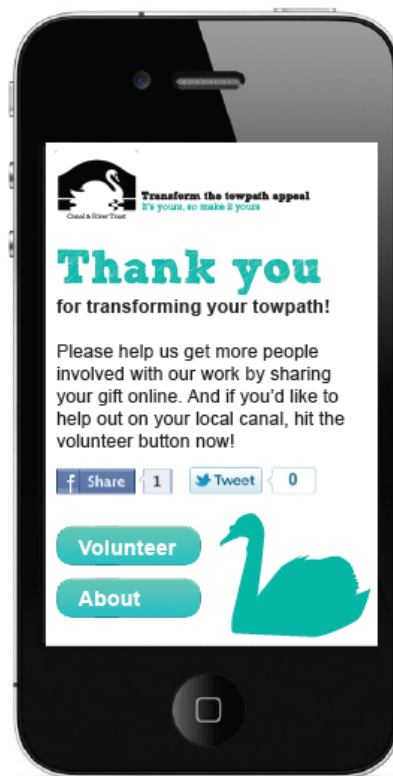

Ruth Ruderham then explained the plans for public fund raising, which it was estimated, will raise 10% of the income required. Over the first 10 years it was hoped to enroll 100,000 supporters and raise £10 million per annum. This would include a "Friends of Canal & River Trust" scheme. There would be opportunities for

commercial sponsorship and corporate partners, some of whom have already signed up, but Ruth expected the general public would be the major contributors.

Modern technology would be used to allow the public to help in funding schemes that appealed to them. A practical way to do this would be to install display boards on the towpath showing, for example, proposed improvements to the canal and it's towpath and giving a phone number to pledge a donation from a mobile phone. The caller would then be thanked and asked if they would consider becoming a friend of the waterways.



In closing Ruth offered the following ways AWCC members could become involved.

## Fund-raising

- Select local projects and help fundraise for these amongst members and in the community
- Promote Friends scheme to members – and become some of our first Friends yourselves!

## Volunteering

- Consider a community adoption of your local mile stretch.
- Suggest companies with whom you could partner on an adoption.

This automatically connects to the police authority from where the call comes, with an option to request another police area, should you wish. Graham Churton, Rear [Cruising] Commodore of Stoke on Trent Boat Club organised an unusual 'Will it fit' competition as part of their Easter cruise. ## L&L SWING BRIDGE

Malcolm Holbrook tell us that that BW have completed the conversion of the notorious Crabtree swing bridge (32) outside the SLIPWAY Pub at Burscough to electrically operated (it was the bridge that you had to turn 18 or 20 turns with a windlass).

He says, "When I went through at the week-end I was astonished to find that the control panel is on the TOWPATH SIDE. Maybe BW have at last got the message that it is safer for both single-handed boaters and inexperienced crew if the steerer can get to the control panel. The system is not without its faults, the LCD screen is small and the instructions are difficult to read, especially in bright sunlight, and worse still if you do not have your reading glasses with you. There is no protection to the screen and so vandals will have a field day. It should have a BW key lockable stainless steel cover for protection. The other potentially more serious problem is the emergency stop button which is in the middle and not covered. Anybody (including vandals) can push it easily resulting in the bridge locking in the position at the time and requires a B.W. call out to reset it. So to BW, for once, congratulations on at long last heading the problems of single-handed boaters."

Ian and Vera Short recently presented a cheque for over £500 to Clatterbridge, the Wirral based specialist cancer hospital. This was funds raised by the members of the Bridgewater Motor Boat Club during Ian's 12 months term as Commodore. Various raffles and fund raising events all helped boost the grand total.

A long standing member of the BCN Society, Graham offered his services as Chairman at the end of 2007. He oversaw the celebrations for the 40<sup>th</sup> anniversary of the Society and the 1858 Dudley Canal improvements. He also assisted with a new project being launched by the IKON Gallery. All involved in this project, particularly the young people, found him to be extremely helpful and supportive.

All who knew Graham will be aware that they have lost a good friend of the waterways.
