Facilities at BWML [Lemonroyd Marina](#) (Aire & Calder) have been closed to general boaters with a change of locks keys only being made available to BW marinas moorers.

Since the demise of [Sagar Marine](#) at Brighthouse (Calder & Hebble) pump out facilities have been lost between Sowerby Bridge and Stanley Ferry. Concerns relate to both inconvenience and environmental considerations. Initial representation to BW has not been promising as they have stated that the cost of installing card reader systems are prohibitive.

Tinsley Boat Club (Sheffield & South Yorks) are pleased to report removal of a longstanding sunken boat much due to the efforts of retiring Chairman Bob Mennell.

### AWCC must get up to date

Every month I get a copy of each of the principal waterway magazines. Inserted in one was an informative leaflet published by the Association of Waterways Cruising Clubs (AWCC). But the problem was that it was out of date on at least two counts simply because it was produced in 1994 - at least that's what it said.

The leaflet stated that the AWCC “is consulted by waterways administration” including the National Rivers Authority and had contact with other user groups including the Inland Waterways Amenity Advisory Council (IWAAC) and the Waterways Parliamentary Group.

I would respectfully point out that the Rivers Authority disappeared with the birth of the Environment Agency, the IWAAC dropped the word Amenity to become IWAC and then disappeared with the Government's cull on quangos. Finally, the correct term is the Parliamentary Waterways Group NOT the Waterways Parliamentary Group. Methinks an eye for detail is now needed.

Response below from Paul le Blique AWCC National Chairman following publication of the misleading letter (above) was spotted in ‘Canals, Rivers & Boats’ in January 2012:

It was difficult to decide if irritation or amusement was the appropriate reaction to this letter as it is misleading and ill-informed; for as I am sure readers will know, AWCC is at the forefront waterway matters just as it was eighteen years ago when the leaflet referred to in the letter was written. AWCC is unaware how the leaflet came to be distributed as the association has no formal link to the waterway press. Keep an eye on the magazines for an official article on the association.

### **New notification service for AWCC ALERT Newsletter**

November 2011 sees the launch of a new service to Clubs and individual Club members.

This ALERT newsletter is published three or four times a year and for many years has been circulated to Clubs as a paper copy. More recently, we have produced an electronic version as a PDF file which has been available on the AWCC website at <http://awcc.org.uk/alert>. However until now we had no way to inform AWCC members or Clubs when the latest version had been published.

The AWCC ALERT notification service will send you an eMail whenever a new version of ALERT is available on the AWCC website. The eMail will include a clickable link which will download the PDF version of ALERT to your computer or smartphone.

To sign up to the service for a personal notification, please go to the web link below and follow the instructions there.

Smartphone users can scan this Q-Code to get to the link directly from their phone.



Once you have submitted the subscription form, you will receive a link eMail asking you to confirm your subscription request. You need to respond to this email and confirm your request. You will receive one further eMail confirming your details, so you know your registration is confirmed.

You can unsubscribe at any time from the service by clicking the link on any eMail your receive.

We have already contacted all Club secretaries asking if they would like to receive an electronic copy rather than being sent a paper copy by post. Clubs who opt in to this service help reduce the costs of producing and distributing ALERT, which helps us to keep costs to a minimum. Any Club who does not subscribe to the service will continue to receive a paper version by post.

*(For your information, the service we are using is managed by Mailchimp <http://mailchimp.com> and the AWCC has a free account to the service which does not cost us anything. However you should be aware that the details of your subscription are held on a host system outside the UK and therefore may not be covered by UK Data Protection Law. The information you provide is used only to notify you of new versions of ALERT and will not be used for any other AWCC services or passed on to any other parties.)*
